## ABOUT THE MAASTRICHT UNIVERSITY SYMPOSIUM ON SEXUAL VIOLENCE

Sexual and gender-based crimes, victimizes women, men, girls and boys alike and they often have lasting individuals consequences for and Though communities. significant progress has been made in addressing these crimes with respect to the female gender, much remains to be done for the male gender. It is against this backdrop that we are organising a symposium, titled "Sexual Violence: The Male Perspective", with focus on the theme 'Unseen, Unheard, Unspoken', scheduled to hold on the 15th February, 2019, at Turnzaal, Grote Gracht 90-92, Maastricht University, Maastricht, The Netherlands from 13:00 to 18:00.

Sexual violence is largely identified

as a menace which is eating deep into our society both in conflict and peace situations yet; many aspects of it have been left rarely or entirely undiscussed. Sequel to the 20th anniversary of the Rome Statute of the International Criminal Court and other very significant developments that occurred in international law in 2018 pertaining to prosecuting conflict related sexual violence perpetrated against males, Centre for African Justice will be organizing a symposium on sexual violence against males, in our efforts to contribute to the nurturing of the criminal justice system in the area of sexual violence.

Accordingly, in line with the United Nations International Day for Elimination of Conflict related Sexual Violence celebrated on June 19 every year, this conference hopes to discuss the UN's responses to sexual violence against men and boys in armed conflict, to better understand the problem and explore possible measures of prevention and protection of the male victims from the UN perspective.

Through the conversation arising from this conference and the information that would be shared by the resource persons plus the interactive sessions among the participants, recommendations will be made and action plans developed with respect to closing the gap surrounding sexual violence against men and boys and possible ways of exchanging best practices between international and domestic jurisdiction. One of such best practices could be the definition of rape



and some other forms of sexual violence which is usually narrow in domestic jurisdictions and broad in international law.

There is mounting reports of the issue that calls for urgent action. The issue has been brought into sharp focus at the global level by studies undertaken by International bodies and litigations handled by international courts/tribunals. However, much remains to be done.

### **BIOGRAPHY OF SPEAKERS**

THE AMBASSADOR OF BOSNIA AND HERZEGOVINA TO THE KINGDOM OF THE NETHERLANDS, H.E. MS. MIRSADA ČOLAKOVIĆ



Prior to her appointment as the Ambassador of Bosnia and Herzegovina to the Kingdom of The Netherlands and

the Permanent Representative to the OPCW in 2016, Ms. Čolaković held the post of the Permanent Representative to the United Nations for the Permanent Mission of Bosnia and Herzegovina from 2012 to 2016. Ms. Čolaković was also previously the Deputy Permanent Representative to the United Nations for the Permanent Mission of Bosnia and Herzegovina, a post she held from 2005 to 2012. From July to November 2005, she headed the Department of International Cooperation in the Fields of Science, Technology, Education, Culture and Sports within the Ministry of Foreign Affairs in Sarajevo.

Between November 2002 and June 2005, Ms. Čolaković served as Deputy Head of Mission in her country's Embassy to the United States, having held the same rank at the Embassy in Greece from November 2000 to October 2002, with concurrent service as Chargée d'affaires for the period April 2001 through 2002.

Ms. Čolaković served as an Adviser in the Office of the Deputy Foreign Minister from June 1999 to November 2000, prior to which she worked in the Office for Foreign Relations of the President of Bosnia and Herzegovina, from June 1998 to July 1999.



After joining her country's foreign service in 1995, she served in multiple capacities at the Embassy in Brussels, Belgium, and in Bosnia and Herzegovina's missions to the European Union, the North Atlantic Treaty Organization (NATO) and the Council of Europe.

A professor of philosophy and sociology at the University of Sarajevo, Ms. Čolaković completed her post-graduate studies at the University of Belgrade in 1983, having earned a specialization in European Institutions and Lobbying at the Institute for European Studies in Brussels, in 1997.

Mr. Kazi Russel Pervez joined the Embassy of Bangladesh in The Hague as Counsellor in August 2015. He is also concurrently accredited to the Organization for the Prohibition of Chemical Weapons (OPCW) as Alternate Permanent Representative of Bangladesh.

Mr. Kazi Russel Pervez served in Bangladesh Embassy in Bangkok for the period 2012-2015 as First Secretary/Counsellor with concurrent accreditation to the United Nations Economic and Social Commission for Asia and the Pacific (UN ESCAP) as the Deputy Permanent Representative of Bangladesh. Mr. Russel Pervez served in the Ministry of Foreign Affairs, Dhaka as Assistant Secretary/ Senior Assistant Secretary for the period 2004-2012.

Before joining Bangladesh Foreign Service, Mr. Kazi Russel Pervez briefly served the Government of Bangladesh as an Assistant Commissioner & Magistrate for the period 2001-2003 and also as an Assistant Engineer, Local Government Engineering Department during 1998-1999.

Mr. Kazi Russel Pervez completed Master of Economics in Socio-Economic System from Nagoya University of



Japan. He also obtained Master of Business Administration from the Institute of Business Administration, University of Dhaka, Bangladesh; and Bachelor of Technology in Civil Engineering from the Indian Institute of Technology, Delhi, India.
