Introduction / Overview of the Foundation

Stichting Centre for African Justice, Peace and Human Rights (CAJPHR) is a non-profit foundation located in the "city of peace" and legal capital of the world in the Netherlands. Its head office is located at Laan Meerdervoot 70, 2517 AN, The Hague, The Netherlands. CAJPHR started as a human rights initiative in Africa and consequently, in 2017 became a legal establishment in the Netherlands. The organization primarily focuses on promoting justice, peace and human rights with the aim to create local and international partnerships that would be of great value to the organisation's mission statement. Currently, the organization has four main departments with projects it proposes to accomplish within the next three years. They are:

- **Sexual Violence Department:** This aim of this department is to create awareness on conflict-related sexual violence perpetrated against the male gender; for a better recognition and support system for males victims of sexual violence; and advocate for a review and amendment of domestic laws were necessary. Our goal is that through the projects under this department, we would be able to create a platform that would educate, empower and support the victims of this crime and give them a platform to understand that they are not alone in the journey of recovery.
- Women Empowerment Department: The core objective of this department is to organize conferences that would motivate, coach and empower young African women to become independent and enlightened on their rights as women and their roles as instruments of peace in the society. Empowerment in our context includes providing them with skills and information that would enable them to achieve their highest potential in life without necessarily engaging in any form of abuse or illegality.
- **Right to Quality Education Department:** This department provides facilities to improve the quality of education in Africa. Having observed that there are many schools in Africa which have a very low standard of education due to lack of certain infrastructures, our Foundation provides

necessary facilities that would improve the standard of education in some of the schools. Our most recent project was at a school in West Africa with 700 children and about 25 Staff. As our contribution towards the right to quality education in Africa, we provided the school with toilet facilities and access to clean water.

- Capacity Building Department: This department cuts across many spheres, limited but not restricted to developing a platform that would broaden the expertise and capacity of lawyers, judges, magistrates and law students in Africa. The organisation envisions that through this department, it can become a frontline model in identifying opportunities and exposure in the international labour market, particularly for young lawyers and law students who have the desire to be trained or acquire the right skills for the national and global labour market. We hope to accomplish this by organizing workshops, working visits, conferences, professional training and mentorship programmes for legal practitioners in Africa, with the help of both national and international academic institutions plus organisations working on international criminal law.

Chairperson's Report

It is with great pleasure that I present to you the first one-year financial report of our Foundation which is from October 2017 - October 2018. In the first year, CAJPHR performed magnificently despite operating under zero capital. CAJPHR which started with 20 volunteers swiftly increased to 35 volunteers and 10 interns by 2018. Also in 2018, it employed representatives in a number of African countries and entered collaboration and partnerships with other non-governmental organizations, embassies and academic institutions. The organisation has four different departments and has since sustained them through the years to date. The sustenance of the projects under these departments could not have been possible without the involvement of our various donors, Board members, committee members, advisory members, partners, volunteers, interns, friends of the organization and all others well-wishers who immensely contributed their intellectual

and material resources towards the growth and success of the organisation through the year 2017 - 2018. On this note, I wish to use this medium to give a special appreciation to all our financial partners and donors for their unwavering trust, support and partnership. Thank you once again for helping us actualize the vision and mission of the Centre for African Justice, Peace and Human Rights. Thank you also for your cooperation and we pledge to keep the flag flying as we continuously pursue the core vision of the organisation.
